DELIVERY: To address specified by lessee (customer). Lessee grants *Fun Times Party Rental* and its employees/contractors, the right to enter said property for the delivery and return of rented equipment at approximate times. All payments must be made at time of delivery. No refunds will be made after equipment has been delivered. Customer is subject to an additional charge of \$40.00 for all service calls due to electricity or preventable services. **USER MUST FURNISH ELICTRICAL OUTLET WITH SLO-BLO FUSE OR minimum 20 AMP FUSE CIRCUIT WITHOUT ANYTHING ELSE CONNECTED TO CIRCUIT. USE ONLY 50 FT EXTENSION CORDS FURNISHED BY FUN TIMES PARTY RENTAL. OTHERS MAY CAUSE MOTOR TO BURN UP!! USE ONLY ONE BLOWER PER ELECTRICAL CIRCUIT.** Generators are available for an additional fee, with advanced notice for areas without proper electrical requirements.

Bounce House:

GENERAL RULES: Units must be operated over a smooth, compatible surface such as grass or hard top surface. The unit may NOT be operated on rough surfaces such as rocks, bricks, glass, or any jagged objects. **UNIT MUST BE PROPERLY ANCHORED PRIOR TO USE AND DEFLATED IN HIGH WINDS OR GUSTY WINDS, THUNDERSTORMS OR LIGHTNING.** Unit was initially anchored by _____. In the event of power failure, severe weather alert, or medical emergency; have patrons exit in a timely and orderly fashion, turn blower(s) off and disconnect plug from power source, keep patrons and guest away from inflatable, and call appropriate emergency responders if necessary. *Fun Times Party Rental* is not responsible for bad weather, disruptions in electrical service or and unfavorable conditions, not within its responsibilities, and no charges or fees shall be reimbursed. NEVER locate unit within 5 feet of pole, wall, or fixed objects, or overhead obstructions. Only children of the same age group should play on unit at the same time. The maximum number of riders in each age group is as follows:

All units that have a slide, riders must slide down feet first and no more than two (2) riders at a time, **NO** climbing on the slide the wrong way, and **NO** jumping on the slide area. All persons must remove shoes before playing on any unit. **TURN OFF AUTHOMATIC SPRINKLER SYSTEMS** in area where unit is to be used. Absolutely no water, food, silly string, bubbles or any other damaging substance of any kind may be used on, in or around units unless described above in "description of items rented" box. **DAMAGE TO UNIT FROM SILLY STRING, OR LIKE PRODUCT, IS PERMANENT AND LESSEE WILL BE HELD RESPONSIBLE FOR FULL REPLACEMENT VALUE OF RENTED UNIT!!!!**

GENERAL RULES FOR SAFE OPERATION: 1)Never play or jump on partially inflated unit. 2) Do not allow riders to play, climb, on outside or inside walls, columns, netting or roof of unit. 3)ALWAYS follow manufacturers guidelines located on unit itself. 4) ALWAYS follow number of riders and rules posted on unit itself. 5) Do not plug and unplug motor repeatedly as it will cause it to burn up. 6) Always have an adult present to supervise riders. 7) Never place a hose or water on unit unless authorized in "description of rental unit" above. 8) In case of rain, remove riders and unplug blower and extension cord from wall outlet. 9) Do not allow horseplay on units. 10) Follow all rules posted on unit. 11) **ABSOLUTELY NO SILLY STRING OR SIMILAR ITEMS IN OR AROUND UNIT AT ANY TIME!!! SILLY STRING, AND LIKE PRODUCTS, WILL CAUSE PERMANENT DAMAGE TO UNIT AND LESSEE WILL BE HELD RESPONSIBLE FOR FULL REPLACEMENT VALUE OF RENTED UNIT!!!** In the event of power failure, severe weather alert, or medical emergency; have patrons exit in a timely and orderly fashion, turn blower(s) off and disconnect plug from power source, keep patrons and guest away from inflatable, and call appropriate emergency responders if necessary.

Kid Steam Train:

GENERAL RULES: Units must be operated over a smooth, level, and compatible surface such as grass or a hard top surface. The unit may **NOT** be operated on rough surfaces such as rocks, bricks, glass or any jagged objects. **FUN TIMES PARTY RENTAL** is not responsible for bad weather, or any unfavorable condition, not within its responsibilities, and no charges or fees shall be reimbursed. *Fun Times Party Rental* is not responsible for bad weather, disruptions in electrical service or and unfavorable conditions, not within its responsibilities, and no charges or fees shall be reimbursed. NEVER locate unit within 5 feet of a pole, wall or fixed object or overhead obstructions. Only children of the same age group should play on unit at the same time. The maximum weight for each rider is 100 lbs, and only children ages 3-13 within the weight requirement shall ride. **NO ADULTS ARE ALLOWED TO RIDE TRAIN, AND NO PERSONS OVER THE AGE OF 13 ARE ALLOWED TO RIDE TRAIN.** . Absolutely no water, food, silly string, bubbles or any other damaging substance of any kind may be used on, in or around units unless described above in "description of items rented" box. **DAMAGE TO WILL MAKE LESSEE RESPONSIBLE FOR FULL REPLACEMENT VALUE OF RENTED UNIT!!!!**

GENERAL RULES FOR SAFE OPERATION: 1) **ADULT SUPERVISION IS REQUIRED. CHILDREN SHOULD NO OPERATE TRAIN OR UNIT WITHOUT AN ADULT PRESENT.** 2) Never play or jump on any part of train unit. Train unit contains moveable parts and children not riding are required to keep a safe distance of six feet away from the train at all times when not riding. 3) Absolutely no touching, sitting, standing, jumping or placing objects directly on track. Only an adult can touch the track, but only when needed or necessary. 4) Keep hands, and all body parts inside of unit when riding. 5) Do not enter or exit unit until it has made a complete stop and an adult assists with entering and exiting the unit. 6) **ALWAYS** follow weight and age requirements listed above. 7) Never place a hose or water on unit. 8) In case of rain, do not ride unit. 9) **Do**

not allow horseplay on unit. 10) Follow all rules. 11) **ABSOLUTELY NO SILLY STRING IN OR AROUND UNIT AT ANY TIME!!!! SILLY STRING, AND LIKE PRODUCTS, WILL CAUSE PERMANENT DAMAGE TO UNIT AND LESSEE WILL BE HELD RESPONSIBLE FOR FULL REPLACEMENT VALUE OF RENTED UNIT!!!!** 12) **LESSEE AGREES TO INFORM ALL RIDERS OF THE RULES, AND LESSEE AGREES TO ENFORCE ALL RULES.** In the event of power failure, severe weather alert, or medical emergency; have patrons exit in a timely and orderly fashion, turn blower(s) off and disconnect plug from power source, keep patrons and guest away from inflatable, and call appropriate emergency responders if necessary.

PICK UP: Lessee agrees to return equipment to *Fun Times Party Rental* in same condition as received and at agreed upon time. If unit is excessively dirty upon pickup (ie. Mud, dirt, food, drinks, spills, piñata, confetti, gum, etc.) or unit is excessively wet from sprinkler systems and/or garden hose, unless authorized in "description of rental units" above, lessee agrees to an additional \$50 clean up fee along with any additional charges from lost rentals while unit is being cleaned. **DAMAGE FROM SILLY STRING, AND LIKE PRODUCTS, IS PERMENENT AND LESSEE WILL BE HELD RESPONSIBLE FOR FULL REPLACEMENT VALUE OF RENTED UNIT.**

TERMS OF LEASE: Lessee MUST provide own liability insurance unless otherwise specified. Lessee is responsible for compliance with all city codes and HOA rules, prior to rental. Lessee is responsible for the replacement value of the rented units in the event of theft, vandalism, fire, or any other act that may damage or destroy the leased property, in the care of the lessee. Lessee is responsible for returning all equipment and property in same condition as received. If a check is returned as unpaid, the amount of the check plus additional \$50.00 service charge must be paid upon notification. If payment is not received within 10 days of notification, the check will be turned over to an attorney for collection of all outstanding fees and additional fees, including attorney's fees and court cost. Failure to observe terms in this agreement, or failure to make payment, or failure to have *Fun Times Party Rental* equipment available for return per agreement, shall make lessee liable to *Fun Times Party Rental* for an additional one day rental fee, per day, until all equipment is returned in proper working order, plus any additional court, legal, and/or attorney's fees incurred in order to obtain return of rented property.

HOLD HARMLESS PROVISION: Lessee agrees to indemnify and hold *Fun Times Party Rental* harmless from and all claims, actions, suits, proceeding costs, expenses, damages, and liabilities, including reasonable attorney's fees arising by reason of injury, damage, or death to persons or property, in the connection with or resulting from the use of equipment including, but not limited to the manufacture, selection, delivery, possession, use, operation, or return of the equipment. Lessee hereby releases and holds harmless *Fun Times Party Rental* from injuries or damages incurred as a result of the use of said equipment. *Fun Times Party Rental* cannot under any circumstance be held liable for injuries as a result of acts of God, nature, or other conditions beyond its control of knowledge. Lessee also agrees to indemnify and hold harmless *Fun Times Party Rental* from any loss, damage, theft, or destruction of the equipment during the term of this contract and any extensions thereof.

DUTY TO MITIGATE: In the event of injury, damage, or loss due to *Fun Times Party Rental's* negligence, Lessee agrees and assumes the duty to mitigate all costs resulting from said injuries, damages, or losses.

DISCLAIMER OF CONSOQUENTIAL DAMAGES: By signing this contract, Lessee agrees to forgo seeking and consequential damages in the event of any injuries, damages, and/or losses due to *Fun Times Party Rental's* negligence.

DISCLAIMER OF WARRANTIES: *Fun Times Party Rental* makes no warranties either expressed or implied as to the condition or performance of any equipment and/or property leased by lessee from *Fun Times Party Rental*. By signing this contract, lessee agrees that any warranty of merchantability or fitness for a particular purpose are herby disclaimed. By signing this contract, lessee agrees that no express warranty as to the condition or performance of any equipment and/or property leased by lessee is disclaimed. Lessee understands that the only warranties pertaining to the condition or pertaining of said equipment and/or property is that which is stated on the instruction manual for said equipment and/or property.

MERGER CLAUSE: This signed Agreement in conjunction with the signed Instruction Manual and Reservation Form contains the entire agreement between *Fun Times Party Rental* and lessee. No amendment, whether from previous or subsequent negotiations between the lessee and *Fun Times Party Rental*, shall be valid or enforceable unless in writing and signed by all parties to this contract. The invalidity or unenforceable of any particular provision of this Agreement shall not affect the other provision hereof.
